3 The board shall annually establish and review the strategic plan to guide the operations of
4 the district. All personnel in the district shall direct their efforts toward achievement of the plan
5 in order to ensure that students are able to function effectively in their environment, employment,
6 and continuing educational efforts. (See BA)

7
8 The board shall participate in strategic planning through an annual meeting with the
9 superintendent and designated staff to review progress on the implementation of the plan's
10 priorities. The board also shall consider and act upon objectives and major activities proposed
11 by the superintendent to achieve identified goals.

12
13 The superintendent shall develop necessary procedures, forms, or other measures to
14 implement this policy.

15
16 The superintendent shall provide opportunities for interested patrons to become
17 knowledgeable about the district's strategic planning process and to review and make
18 recommendations concerning specific district goals.

19
20 The superintendent shall give the board periodic reports.

13 If change is necessary, the superintendent shall, on or before April 1 of each year, prepare a
14 written report for the board, which report shall contain recommendations concerning the changing
15 of school attendance areas for the succeeding school year and the reasons for such recommenda-
16 tions. The board shall consider such recommendations at the first regular meeting following receipt
17 of said report but shall take no action on the report at that meeting. The changes recommended shall
18 be given to the news media for publication in order that the patrons of the district may be made
19 aware of possible attendance area changes and have an opportunity to appear before the board and
20 express their opinions in regard to the recommended boundary changes. The board shall take no
21 action on the recommended changes until after the patrons of the district have had an opportunity to
22 appear before the board.

12 On or before the first regular meeting scheduled in March of each year, the
13 superintendent shall present to the board a recommended school calendar for the next school
14 year. In making such recommendation, the superintendent should be prepared to minimize
15 conflicts with religious holidays of all faiths and shall consider the customs of the district, legal
16 holidays and other relevant matters. The superintendent shall also consider the recommendations
17 of the district's staff in the preparation of the school calendar, but the adoption of the school
18 calendar shall not be a subject of discussion in the negotiating process except as provided by law.
19 A copy of the current annual calendar shall be on file in the clerk's office.

1 **AEB School Year and Learning Opportunities**

3 Lengthened or Shortened School Year

4 Upon recommendation from the superintendent, the board may lengthen or shorten the
5 regularly scheduled academic year because of the following types of circumstances which are
6 stated by the way of illustration and not by way of limitation: adverse weather conditions,
7 building maintenance problems, personnel problems, public health reasons, or budgetary
8 problems. The superintendent shall be responsible for preparing a plan and presenting it to the
9 board. Should the school year be shortened by board action, the board shall ensure the school
10 term provided includes at least the minimum number of days or hours required by Kansas law.

11
12 Additional Learning Opportunities for Students

13 The board may require additional learning opportunities for students not meeting
14 minimum academic standards as defined by the board or as outlined in board policy and/or
15 handbook language. Students may be assigned to additional academic sessions taking place

 - Before- or after-school;
 - 18 • Saturday; or
 - 19 • During the summer.

20

21 Truancy laws, suspension and expulsion policies and law, and all appropriate portions of
22 the student behavior code shall apply during extended academic sessions. (See JBD, JBE, JDD
23 and JCDA)

3 The board is responsible for assessing the use of school facilities and other resources.
4 The superintendent shall seek direction from the board prior to pursuing a district-wide facilities
5 assessment or any study or recommendation leading to the possible closure of one or more
6 attendance centers.

16 Procedures

17 The superintendent will seek board approval prior to conducting a district-wide facilities
18 assessment or making recommendations relative to the possible closing of attendance centers.

19
20 After a school is identified for possible closure and the board has given approval to study
21 the particular situation, an orderly procedure, including timelines and the provision of
22 information to all who will be affected, will be utilized. Parents and other school patrons of the
23 attendance area will be involved in discussions pertaining to the possible closing. Outside
24 consultants may be utilized to assist in the study.

25
26 When the superintendent has made a final recommendation for closure and the board has
27 approved it, the administration will use reasonable means to inform parents of students affected
28 by the closing about their new school assignment.

29
30 Necessary alignment of boundaries will be made when a school is to be closed, taking
31 into account distances from other schools, traffic patterns, building capabilities, enrollments and
32 programs.

33
34 Administrative planning for reassignment of students and staff members, disposition of
35 equipment and furniture, etc., normally will be completed prior to the end of the school year.

36
37 Alternate uses of the building or disposition of the property will be considered in light of
38 current and projected needs.
